Biography of Randolph Gibson and Mary Crowley

RANDOLPH (Randal) GIBSON, born by 1734 (of age 16+ on tax list with father James in 1752 Bedford Co, Va; indicted for swearing in 1755 Bedford Co, age at least 21); died about 1793/4 in Wilkes Co, GA (Tax Digest of Ga); son of James Gibson and Elenor [Early?] of Bedford Co, Va; proved by will of James Gibson who mentioned son Randolph and bequeathed to him his slave Bimbo. Jeremiah Early witnessed James' will. Randolph was listed on 1767 tax list of Pittsylvania Co, Va with his father's slave Bimbo. James also mentioned son Archibald. See Henry Co, Va and Wayne Co, Ky for records of men named Archibald. Randolph married by 1761 to MARY CROWLEY, when her father Jeffrey Crowley wrote his last will and named Randolph Gibson. Mary, b. ca 1737 in Orange or Spotsylvania Co, Va; died by 1798 in Oglethorpe Co, Ga, probably in the home of her brother, Ben Crowley. Ben and Mary were children of Jeffrey Crowley and Effie ____.

Randolph Gibson and Mary Crowley had the following children, all born about 1760-70 (?) in Pittsylvania County. Mary Crowley Gibson was a little over 20 years old when her first child was born. The children are not in order of birth. They were all listed in the Wayne Co, Ky Deed Books as heirs of George Gibson deceased who died intestate without issue. His large estate was divided between his brothers and sisters as follows:

1. JOHN GIBSON, Sr. b. c1760 in Bedford Co, Va; married a daughter of GEORGE YOUNG SR., a long time friend of the Crowley family in Pittsylvania Co, Va. John was named as legatee in George Young Sr's Estate File, 1791 in Wilkes Co, Ga. John Gibson served in Revolutionary War and died before 1838 [Lincoln Co, Tn? pre-deceasing his brother George]; had children who lived in Indiana by 1838:

Luallin [Lewallen] Gibson & Mary his wife of Daviess Co, Indiana

John Gibson Jr. of Daviess Co, Indiana

All children are legal representatives of John Gibson, deceased, representative of George Gibson, dec'd of Wayne...(Wayne Co, Ky Deed Bk G:35-36).

In James Cotton's Revolutionary War File (No.W.6942, Nancy Cotton, widow), ..."JOHN GIBSON testified from Lincoln Co, Tn dated 20 Sep 1832, aged about 72 and declared that in 1781 in Guilford Co, NC he joined a company of mounted infantry commanded by Capt. John May...and James Cotten was in that same company...and marched to fight the Tories..The Testimony of JUDITH STRONG, dated 15 May 1843 in Rockingham Co, NC: She declared she was acquainted with James Cotton and Nancy Johnson before they married. She was at the wedding of William Cotton's the uncle of James Cotton. They were married about 57 or 58 years ago. James Cotten's file states in January 1781, while visiting his relatives in HENRY CO, VA, HE SUBSTITUED for JOHN NANCE in Capt. George Harston's [Hairston] Company of men drafted from that county for a 3 month tour in NC to assist in combatting the British and Tories who then infested that colony." Cotten's unit mustered on 1 Jan 1781 about 2 months prior to the call given JAMES CROWLEY'S unit commanded by Thomas Henderson.

[Note: Judith Strong was nee Hardeman, dau of John Hardeman and Dorothy Edwards. Judith married Sneed Strong].

- 2. JESSE GIBSON, b. ca 1767 Pittsylvania Co, Va; d. Oct 1838 Livingston Co, Ky; admr. Samuel Gibson; left nun-couperative will; m. ca 1798-9 in Knoxville, Tn to Elizabeth Parmley, b. 1784 Wilkes Co, Ga; d. 4 Feb 1854 Hardeman Co, Tn. buried Gibson Cemetery; dau of Ephraim Parmley Sr and Mary Hines; Ephraim Parmley Sr, b. ca 1760; d. after 1825 in Livingston Co, Ky; son of Giles Parmley, son of Hiel Parmley, son of Nathaniel, son of Nathaniel, son of John, son of John. Ephraim served in Rev. War from Wilkes Co, NC; lived in Wilkes Co, Ga with Randolph Gibson family; went to Livingston Co, Ky early and had land grant on Deer Creek that he patented in 1805 and where he later died; Jesse Gibson first appeared on the Livingston Co, Ky Tax List in 1808 and had 100 acres on Deer Creek; 1 Negro slave and 3 horses. Jesse and Elizabeth continued living in Livingston Co until his death and then Elizabeth moved to Hardeman Co, Tn and lived with son George. She died there. They had children: (see Jesse Gibson's sister, Catherine below. She m. John Parmley, son of John, brother of Ephraim). The name of Parmley is also found as "Parmelee, Palmerlee, Parmaly, Parmale, plus over 100 other spellings.

Elizabeth Strong (1742-c1798 in Jackson Co, Ga). "Deceased SISTER, POLLY CROLEY'S (Crowley) children " (Wayne Co, Ky Deed Bk H:82-83). "RANDALL GIBSON being led to the Bar in custody of Field Jefferson, Gent, of this county, to whose custody he was before committed, being charged with the felonious taking and converting to his own use a coat of the property of one William Pool, and for other suspected crimes by him supposed to be committed, and his charges being read, upon examination denied the fact with which he stands charged"

"Whereupon William Pool Jr, William Stroud and JOHN HAWKINS are sworn and examined afore-sworn the premises and the prisoner fully heard in his own defense. On consideration whereof and of the circumstances relating thereto, it is the opinion of the Court that the said prisoner ought to be tried for the capitol, in the City of Williamsburg on the 6th day of the next court and therefore he is remanded to jail in order to be conveyed from thence to the public jail.

"William Pool Jr, being first sworn deposeth that the coat produced at the Bar with RANDOLPH GIBSON, the prisoner, is the proper coat of him, the said William, and that the same was STOLEN FROM HIM out of the dwelling house of William Pool, his father on Sunday night the 10th of March, last past and that the door of the said house was then shut with a latch.

William Stroud being first sworn saith that he in company with JOHN HAWKINS apprehended and took the prisoner now at the Bar on the 20th of March, last past, and that he found in his possession, the coat produced at the Bar, one STRIPED VIRGINIA CLOTH GOWN, a REMNANT of 3 • YARDS of WHITE HOLLAND, an OLD DIASA TABLE CLOTH, a GREY HORSE, BRANDED ON THE NEAR BUTTOCK "AG" and an old SADDLE and BRIDLE, a LINEN WALLET, and a PISTOL CHARGED, and further this deponent saith not.. /s/ William (x) Stroud"

"Be it remembered that on the 2nd April in the 6th year of the reign or our sovereign Lord, George II, by the Grace of God, King of Great Britain, France and Ireland, Defender of the Faith, and before the Justices of the County of LUNENBURG, aforesaid, at the Courthouse came William Pool Sr, and acknowledged themselves severally indebted unto our said Lord, the King,

in the sum of 20 pounds sterling, of the respective goods and chattels, lands and tenements to be levied and to our said Lord, the King, his heirs and assigns rendered; yet upon the condition that if the said William Pool, William Stroud, John Hawkins, and William Pool Sr, shall make their personal appearance at the Capitol in the City of Williamsburg on the 6th of next General Court, then and there to give evidence .. against RANDALL GIBSON, touching a certain felony whereof he stands accused and shall not depart thence without leave of the said Court, then this recognizance to be void..

/s/ William Pool, William (x) Stroud, John Hawkins, William Pool" (p.619-622).

"On the motion of William Stroud, a witness for our Sovereign Lord, the King, against RANDALL GIBSON. It is ordered that he paid for 2 days attendance and for once coming and returning 26 miles according to law" (p.626).

"On the motion of John Hawkins, a witness for our Sovereign Lord, the King, against RANDALL GIBSON. It is ordered that he be paid for two days attendance and for once coming and returning 26 miles, according to law" (p.627).

"William Stroud personally appeared in Court and being sworn, depose that the night after RANDALL GIBSON was taken by him, the deponent and John Hawkins, whether the said Hawkins was guarding and taking care of the said Randall, the dwelling house of the said John, with sundry household goods therein, was burnt down, consumed and destroyed, which deposition is ordered to be certified" (p.642).

[Note: Field Jefferson that had Randall Gibson in custody was the final husband of the mother of Mary Allen Fields - see Rockingham Co, NC Gibson records, per James Rolff).
