# Information Furnished By:

MR. TERRELL RAINWATER, MR. CHARLES RAINWATER, & MR. LYLE RAINWATER

JOHN RAINWATER was born near Danbury, Virginia in 1695. His parents are believed to have been English or possibly German. John later moved to Surry County, North Carolina and married MARY FUSSELL, the daughter of THOMAS and FRANCIS FUSSELL, on 24 June 1735.

In 1739, King George II of England granted John Rainwater 400 acres of land bounding on the south side of Roanoke River and lying in what was then Edgecomb County, North Carolina, later subdivided into Edgecomb and Granville Counties. (See petition for AARON FUSSELL).

Mary was born ca 1708-10 and died ca 1782 in Surry County, North Carolina.

John died May 1777 in Surry County, North Carolina. His will was made 4 November 1771, Nine children are named in the will, as well as Mary, his wife.

## . WILL OF JOHN RATHMATER FILED TH SURRY COUNTY, NORTH CAROLINA - MAY 1777

I, John Rainwater of Surry County in No. Carolina, being now in perfect sense and remory, Thanks be to CCD, but yet considering that life and sense is uncertain, do make and ordain this my lest Will & Testament (Viz) My soul I recommend unto the Hands of Cod. My body I recommend to the earth to be buried in a Christian manner, as to my worldly estate I give, dom'se, bequeath and dispose of the same in the in losing manner and form.

F.c.t, I give to my daughters Mary, Betty, Winney, Milley and Molley, to each Five Shillings Frox., money to them and reised out of my estate the same is in full, and a tur from tham obtaining any more.

Iton\_\_\_ I give to my son John Five Shillings Prov., money to be raised as aforesaid the same is in full and a bar from his obtaining any more unless he should succeed his brother James as trustee in the management of that part of my estate which I give for the support of my wife and son William.

Item\_\_ I give my plantation and all my land my negro man Jack and all other my entity of what kind scener to the whole and sole use, support and maintenance of my wife and son William during their lives and do horeby will and subject the same into the hands, care end management of my son James whom I hereby constitute and make Trustee hards, care and management of my son James whom I hereby constitute and make Trustee to uppropriate the said estate to their sole use, support and maintenance as aforesaid, to there either jointly or single in such way and manner as the said James shall judge and think most to their profit and best for their support and comfort. And if any part of the said estate should remain after their decease my will and intent is that he the said James, his heirs and assigns enjoy the same forever.

Item\_ If my son James decease before my wife and son William, I will that my son John succeed my said son James in every point as Trustee.

Locally \_\_I appoint my wife, Mary, Executrix and my son John and James, Executors of this my last will to see that all things be performed according to the true intent and meaning thereof. And I do hereby disamulend revoke every former will and ratify soil on Fire this and no other to be my last will and testament. In witness whereof I have become up hand and seal, this Fourth day of November, 1771.

Signed, shaled, published proximeed and declared in the presence of us.

North Carolina, Surry County, May Court, 1777:

Jesce Eriop, one of the subscribing witnesses to the last will & Testement of John Painmater publish and declare the same to be his last will & Testament, that he was of sound and disposing mind & Memory and that at the same time he san John Pain sign the same as a witness and on motion it was ordered to be recorded.
