GIBBS, Joel

Died before 10 March 1824 when the heirs were on the delinquent tax list. (Crl TN, Co Ct Min, 1/148)

GIBBS, John

Was charged 15 July 1828 with Bastardy by Delila Runnels in two cases. [Delila had also charged Elijah Buris with bastardy on the same day.] John Gibbs made bond with Hugh Barton as security, to keep harmless the County of Anderson from all costs for maintaining the said Bastard children. (And TN, Co Ct Min, 4/171)

GIBBS, John

Made a deed of gift to Jane Gibbs for 400 acres of land on 11 October 1830. (And TN, Co Ct Min, 4/327)

GIBSON, Calvin

Died before 6 October 1869 when S. J. Autry entered a petition to sell land. Calvin Gibson died leaving Espena Gibson, Miranna Gibson, Amanda Gibson, Catherine Gibson and Mary Gibson his only heirs. S. J. Autry has bought all the interest in the land from the heirs except Catherine and Mary who are minors and have no Gardian. J. W. Morgan was appointed Gardian Atitem. (Dec TN, Co Ct Min, 1/46) The land is to be sold subject to the widow's Dowery. (Ibid 55)

GIBSON, Jacob

Was a resident of Bledsoe County 22 March 1817 when his deposition was to be taken for the Plaintiff in the suit of Ramseys Lessee vs David Caldwell. (Rhe TN, Cir Ct Min, A/87)

GIBSON, Jesse

Was charged 20 May 1800 with begetting a bastard child on the body of Elizabeth Parmely and was ordered to pay three dollars per month for the support of said child. (Gra TN, Co Ct Min, 1/140)

GIBSON, Nicholas

Died before 19 August 1805 when the will was proven by James Moore and William Gibson. (Gra TN, Co Ct Min, 2/112)

GIBSON, Roger

Died before 3 May 1875 when Elizabeth Gibson gave bond as Administratrix, with G. W. Still [Stitt] and Dutten Hill as security. C. P. Spence, Sherod Luper and Benjam Harrison were appointed to lay off one years Support to the widdow and family. (Dec TN, Co Ct Min, 2/182)

GIBSON, Stephen

Died before 14 March 1849 when the heirs were on the tax list. (Joh TN, Cir Ct Min, C/445)

GIFFORD, Joseph

Died before 5 February 1855 as shown in the suit of Edward Gifford & others vs Almira McClanahan & husband. A compromise was made by Edward Gifford & John Parker and his wife Francis Parker and his wife Frances [sic] and respondant Martha William Mungle and wife Elizabeth Jabez Gifford the children of T. & L. Keseley Franklin Joseph Lafayette Lucy Alice Kealing and Gid Gifford children of Joseph Gifford and [blank] McClanahan and wife Almira the widow of Joseph Gifford. [no punctuation] Joseph Gifford had made a deed of gift to Almira the said widow. The will of Joseph Gifford proven in Macon County Court is not to be contested or disturbed. These names were listed again: B. B. Carter and wife Mary, John Parker and wife Eliza, Francis Parker and wife Francis, William Parker and wife Martha, William Mungle and wife Elizabeth, Jabez Gifford, Gideon Gifford, Franklin Keeling, Joseph Kealing, Lafayette Keeling, Lucy Kelling, Alice Keeling and E. P. G. Gifford, Alexander McClanahan, Almira McClanahan, attest R. A. Bennett & D. D. Claiborne. [Perhaps this last listing was of the ones who signed the agreement] (Mac TN, Ch Ct Min, 1/224)

GILLEY

A suit was shown on 24 September 1856 by Gideon Gilley vs James Cobb et al. Land was sold and title divested out of the defendants Jno. Bateman & his wife Lilla formerly Lilla
