Coryell Probate Bk B-2, cont. from Vol VIII, No. 2 by Ray R. Ward

Page 209. Estate of W. R. CROWDER, dec'd. T. P. HARRISON applies for Temporary Administrator of Estate. (Court is in Vacation). Clerk approves application upon posting \$1000 bond. CROWDER died 25 Sept 1873 in Coryell Co. intestate and that property liable to waste was in estate. J. H. ALLEN was surety on \$1000 bond. Bond approved 30 Sept 1873.

Page 211. Guardianship of DELIA SMITH, a minor over 14. (Court in Vacation). H. M. SMITH applies for appointment as Guardian of the estate of DELIA SMITH. LG (Letters Guardianship) to be issued upon posting \$1000. bond.

Oct. 29, 1873. DELIA SMITH, minor over 14, is cited to appear in court to choose her Guardian. 29 Nov 1873. ELI WOOD & W. D. COATES sureties for \$1000. bond. Bond approved same date.

Page 214. Guardianship of ALEXANDER S., JESSIE T. & VITULA OPHELIA ADAMS, minors. SARAH JANE ADAMS petitions court to become Guardian of the persons and estates of above minors and to be issued LG. LG to be issued upon posting \$5,000. bond. Wards are the minor heirs of GEORGE F. ADAMS, dec'd and are under the age of 14 and have an interest in an estate to be divided 17 Dec 1873 in Abbeville, S.C. SARAH JANE ADAMS is surviving widow.

Citation issued for hearing on 6 Dec 1873. W. W. HAMMACK & D. A. HAMMACK are sureties for \$5,000. bond. Bond approved 15 Dec 1873.

Page 217. Guardianship of WILLIAM C. and CICERO J. JOHNSON. W.J.D. McILHANEY petitions court for LG of estates and persons. He is appointed Guardian and LG to be issued upon posting \$2,500. bond. The children's parents, both deceased, were ISHAM and MINERVA JOHNSON. Children are under 14 years' of age and have property in the county valued at \$500. Citation for hearing 3 Jan 1874. 3 Jan 1874 W.J.G. McILHANEY files inventory of minors totaling \$1,234.85. Appraisers were A.C. GRAVES and J. F. F. DAUGHERTY. 3 Jan 1874.

JOHN F. F. DAUGHERTY and J. N. POWELL sureties on \$2,500. bond; approved 3 Jan 1874. W. J. G. McILHANEY appointed Guardian and LG issued 3 Jan 1874.

Page 222. Guardianship of CORDELIA ANN COX. J. E. EVERETTS applies for guardianship of person and estate. He was appointed Guardian and LG to be issued upon posting \$5000. bond. Bond filed & approved. Order to issue LG to J. E. EVERETTS entered 11 Dec 1873. Property valued at \$2,500. is in Hamilton Co., TX.

Citation for hearing to be held 22 Dec 1873. S. M. ALLEN & J. R. RABY sureties on \$5,000. bond.

Page 225. Estate of T. J. FORE, dec'd. 12 Jan 1874. H. S. PERRYMAN petitions for Letters Administration (LA). Bond is set at \$10,000. Bond approved & LA issued.
