## HUGH CUNNINGHAM - 1858

State of North Carolina, Richmond County Court of Pleas & Quarter Sessions, Jan'y Term A. D. 1858. To the Worshipful, the Justices of said Court:- The petition of B. B. McKenzie, Adm'r of Hugh Cunningham, respectfully showeth unto your Worships:

- 1. That he qualified as administrator of the said Hugh Cunningham at October **Term** 1857 of this Court.
- 2. That from the best information and knowledge which he has been able to obtain the debts due from the deceased amount to about two hundred dollars, and he is of the opinion that the charges of the administration will amount to abt. forty dollars.
- 3. That the personal estate of the intestate according to the best of his opinion and judgement is worth about five [blank space] dollars.
- 4. That the intestate at the time of his death was seized and possessed of a tract of land situate in said County lying on the waters of the Rocky Fork, adjoining the lands of the heirs at law of Duncan McLean, dec'd, containing two hundred and fifty acres of the value of one and half or two dollars per acre.
- 5. That he owned no other real estate, and that said land upon his death descended to Hugh Rainwater and the children of Mary Rainwater, his heirs at law, who are not residents of this State.
  - 6. Your petitioner further showeth, that a sale of the whole of said land is necessary to enable him to pay the debts of his intestate and the charges of administration.

To the end therefore that said tract of land may be sold by your petitioner under a Decree of this Court, upon such terms as your Worships may direct, and that the proceeds of the sale may constitute assets in his hands for the payment of debts and charges of administration. May it please your Worships to require publication to be made for six consecutive weeks in some news paper published within the limits of the State requiring the defendants to be and appear at the next Court of Pleas and Quarte. Sessions to be held for the County of Richmond at the Court House in the Town of Rockingham on the third Monday of April in the year of our Lord one thousand eighth and should and fifty eight, and show cause why a sale of said land should not be decreated.
