Be it remembered that on this the 22nd Feby. 1901, I. D. Gay, Coroner of Richmond County, attended by a jury of good and lawful men, viz., W.B. Cole, R.B. Terry, J. M. Hudson, L. H. Stogner, J. W. Snead, W. L. Scales by me summoned for that purpose according to law after being by me duly sworn and impaneled at Steeles Mills in the County aforesaid did hold an inquest over the dead body of Charley McInnis, and after examination into the facts and circumstances of the death of the deceased from a writ of the copias and all the testimony to be procured the said jury find as follows, that it to say, that deceased came to his death by lick from the train No. 21 going West due from negligence on part of R.R. Co. for not giving a signal.

♣ DANIEL MCINNIS - 1798

William Dawkins, Benjamin C. Dawkins and Mial T. Long, one note of \$40. payable to Daniel McInnis due the 1st day of January 1850 dated the 22nd of March 1849, on this note is a credit of \$25.00 dated December 2nd 1850.

D. J. Grant and Wm. B. Smith, one note of \$50.00 payable to John Yates due 1st Jany 1851 dated the 5th Dec. 1850 on the above note is a credit of \$30 dated Jany 1st 1851.

G. W. McKinnon, one due bill of two dollars and twenty-two and a half cents on demand February the 15th 1848 payable to Daniel McInnis.
