Page 1 - Monday, January 5, 1807

Court held at the Courthouse in Columbia. Present: William Burbridge, Robert Telford, and Herbert G. Waggener, James Gilmer, Hugh French.

Sion Bradley resigns his Office as Deputy Surveyor for this County.

An Inventory and Appraisment of the Estate of Peter Demoss, Decd. returned.

An Amount of the Sale of the Estate of the Sd. Decd. returned.

Stephen White, Senr. take charge of Tomsey Jackson a Poor Girl of this County.

On motion of Meredy Archer, William Allen, William Whitlock, William Stevens and Gabriel Hill do view the best way for a road from the road leading from Columbia to Pulaskia Courthouse, near the County line to Joseph Holts Mill to lead by William Whitlocks.

Page 2 - Monday, Jan. 5, 1807

The Sheriff Pay unto Samuel Brents \$75.00, a balance due him for his Services as an Attorney for the Commonwealth for the Year 1803.

Joseph Holt Jr. appointed Constable in the bounds of Capt. Woolford. Benjamin Stapp and Nathan Coffee his Securities on bond of \$500.00.

John Fox and Banar Compton do Assist in the room of Josiah Wilson and William Robertson, to view the way for a road from Pulaskia road to Sheltons lick.

The several Tavern Keepers within this county may sell Good Brandy and Cherry bounce by the Quart at 4/6 and by the half Pint at 1/6.

James Davis made Proof that as an Actual Settler he had complied with the requitions of the Act of the Genl. Assemby made in Year 1806. He is granted 50 A. on two Creeks and down the River to Todd's line.

Page 3 - Monday, Jan. 5, 1807

Herbert G. Waggoner appointed Commissioner of the upper end, and Thomas Gilmer of the lower end of this County Agreeably to the division made between Sd. Gilmer and Benjamin Bowmar. Wm. McNeely Security for Herbert Waggoner and James Gilmer Security for Thomas Gilmer.

William Burbridge, James Gilmer, Horbert G. Waggener and Danl. Trabue be Commissioners to Contract with some fit Person to locate and secure land for the benefit of a Seminary of lerning.

Benjamin Bowmar and James Leeper are admitted as deputies of Robert Trabue Sheriff.

Page 4 - Monday, Jan. 5, 1807

John E. King resigned his Office as Attorney for the Commonwealth, Whereupon Saml. Brents is app. in his room.

John Field Jailor resigns his Office.

Robert Trabue Sheriff comes into Court and except to the Sufficientsy of the Public Jail.

The Persons appointed to view the best way for a road from near where Alexander Gilmer's line crosses the Burksville road to intersect a road from Burksville to the Mouth of the West fork of Crocus, returned a report. John Votaw, Senr. be Surveyor of so much of the same as lies between near Gilmer's line and the head of Pettett's fork, and Jacob Buckhannon from thence to the County line.

Page 13 - Monday, April 6, 1807

{ The Persons appointed to view a road from the Pulaskia County line to intersect the road from Columbia to Sheltons Salt lick made report. Baner Compton is Appointed Surveyor of the Same.

The Will of Thomas Hardwick, Decd. was Exhibited and proven by the oaths of Joseph Evans, William Weatherington and Richard Weatherington, subscribing witnesses and sworn to by Jno. Grundy and John Hardwick two of the Exors. therein named. Execution of Sd. Will is Granted them reserving the right of Basil Hayden to join in the Probate. They Executed bond of £ 1200 with Joseph Miller and Saml. Brents and Thos. C. Pile their Securities.

Henry White, Joseph Hardin, Richard Gentry, and Benjamin Ball do view the best way for a road from Columiba leaveing the road that leads by John Butlers at an old School house thence by Henry Whites Crossing Green river at Pointers ford thence to Benjamin Balls, Senr. from thence the best way to Carpenters Station as far (?) s _____ to the County line. (tight binding)

Page 14 - Monday, April 6, 1807

Matthew Robertson be Surveyor the road from Campbells ferry to Stanford in the room of Jo _____ Cooley. (tight binding)

Saml. Lee, Robert Christison, Reuben Ball and Joseph Evans do appraise the Slaves if any and personal estate of Thos. Hardwick, Decd.

Ralph Smith be exempt from payment of levies and that he have Credit for levy of last year, It being to the Satisfaction of the Court that because of his age he was unable more than to Support himself.

Page 15 - Monday, April 6, 1807

Joseph Walker be Surveyor of the road leading from Columbia to Summers Meeting House or so much thereof as lies between the junction of the Sd. road with the Barren road and Trabue's Mill in the room of John Telford.

Benjamin Lampton be Surveyor of the road leading from Greensburgh to Burksville or so much thereof as lies between the fork of the Chesnut Ridge and James Vaughans old place in the room of Isaac Truax.

Warner Yates and Saml. Boyd recommended as fit Persons one on whom is to fill the Office of Justice of the Peace.

Page 16 - Monday, April 6, 1807

The Sheriff retain Out of the depositum Money Sufficient to discharge such fee bills as may be Presented agt. the Trustees Of the Town of Columbia at the Suit of William Worley.

Page 17 - Monday, May 4, 1807

At a County Court held for the County of Adair. Present: William Burbridge, Robt. Telford and Herbert G. Waggoner.

The Magistrates Judgment Affirmed.

Page 265 - Tuesday, November 5th 1811

Alexander Elliott, Robert Telford, Robert Trabue, John Shirley,
William Patterson, & John Grissom.

John Stapp resigns his office of Justice of the Peace.

Robert Todd, John Yates, Francis Yates, and Peter Estes are
appointed (in conjunction with the Guardian of the Infant
Orphans of Warner Yates decd.) to divide and set apart unto
James Leeper & Polly his wife late Polly Yates daughter & One
of the heirs of the said Warner Yates decd. their Part of the
lands, etc, of which the said Warner died seized.

Stephen Woodrum stands improperly charged on the Commissioners
Book for 1810 with 400 acres of land the same being twice entered.

Page 266 - Tuesday, Nov. 5th 1811

Present: Thomas Wilson & Robert Trabue.

For reasons appearing to the Court It is Ordered that John
Beard Senr. Jailor be removed from that Office.

The Court proceeded to lay the County levy a statement of which

Pages 368-369 Tuesday, May 4th 1813
 Resolved that after this time no Person except those who have business or are Previledged Shall come inside of the bar of this Court and all Persons who are Previledged or have business in Sd. Court shall address themselves to the Court in Person or by Attorney from the bar, aforesaid Provided for that Purpose, and shall not advance nearer to Said Court than said Bar in making Said motion except for the Purpose of handing to Said Court Some Paper or other instrument for inspection & then shall immediately retire to the Proper Place & that any Persons who Shall be guilty of any of the Offences aforesaid Shall Certainly be fined for a Contempt. & It is further resolved that the Clerk of this Court give notice of this Resolution at the Ct. House door & one or more Public Places within this town as Soon as Possible.

William Owens & William Patterson the Commissioners appointed to Settle with William Burbridge late Sheriff for the levy of 1810 & 1811 made report.

William Owens & Wm. Patterson be Commissioners to examine the Settlements made with the Several late Sheriffs.

Page 370 - Tuesday, May 4th 1813

Page 371 - Monday, July 5th 1813
 At a Court held at the Courthouse in Columbia. Present: William Patterson, Alexr. Elliott, John Grissom & Robt. Tilford.

Henry Brown, Henry Edwards & Meridith Archer are appointed Commissioners to View a way for a road from the mouth of the Alegator fork of Wolf Creek (to which place a road is opened from Wayne Court House) to intersect the road leading from this Place to Summerset at the most Convenient Place.

An Inventory & Appraisement of the estate of John P. Bunderant was retd.

Robt. Hindman is appointed Surveyor of that part of the road leading from this Place to Barren C. H. of which James Atwood was Surveyor.

Page 372 - Monday, July 5th 1813
 John Goode is desirous of erecting a water Grist Mill on the waters of Goose Creek in this County he owning the bed of the Seat of sd. Mill & also the lands on both Sides thereof.

* Solomon Cross be Surveyor of that part of the road leading

from the Pulaski line to intersect the road leading from Columbia to Sheltons Salt lick in the room of Banor Compton.

Page 373 - Monday, July 5th 1813

An Inventory & Appraisement of the Estate of Joel Drake Decd. was returned.

Daniel Harvey labourer who Stands bound by a recognizance to appear here on this day and answer the Commonwealth upon a charge of Vagrancy failed to appear. Said Harvey to appear here on the first day of the next Term to answer to the aforesaid charge.

Page 374 - Monday, July 5th 1813

Elections hereafter to be held in the upper Prescint at Thomas Shaws dwelling House.

Present: John Staton, H.G.Waggener, Dan'l Trabur & Nathan Moore.

Joseph McMullen & Nathan Coffey be recommended as fit persons the one of whom to fill the office of a Justice of the Peace in the vacancy Occasioned by Thomas True's refusing to qualify.

Alexander Elliott & John Grissom be Judges of the Election to be held at the Courthouse for the Present year & that Andrew Ewing be Clerk of sd. Election.

Page 375 - Monday, July 5th 1813

Herbert G. Waggener & Thomas Wilson be Judges & Benjamin Workman Clerk of the Election to be held in the upper Prescinct for the Present year.

Alexander Noel apply any sum not exceeding \$15. to the Support of Mary Eve Moody a Poor woman of this County from this time till the first day of November next.

William Rodgers be Surveyor of that part of the road leading from this place to Barren Courthouse which lies from the foard of the East fork to the top of the first Hill between Big Creek & Long Creek of which Wm. H. Price was Surveyor.

Pages 375-376 - Monday, July 5th 1813

Benjamin Guy be Surveyor of that part of the road leading from Columbia to Stanford which lies between where the road from Green River to Millers Mill Crosses E. Road & the Casey County line & that all hands within five miles of sd. Prescinct not allotted to any other assist sd. Guy & Philip Winfree as Surveyor of one of the Prescincts of
