POLLEY, JAMES WESLEY (Cont'd)

to live with his grdn/mother. Final Report dated Jan. 30, 1893: George W. Polley has reached his legal age of 21. He rec'd \$882.48 by his final receipt dated Jan. 28, 1893. Box 67, file 9.

POLLEY, JOHN C., dec'd - Inventory of Estate Worth \$500.00 or Less, dated May 20, 1876. Widow is Didama (Diadema) Polley; appraisers are Jesse Hall and Ezra Meloy. Land: SW $\frac{1}{4}$ SW $\frac{1}{4}$ , Sec. 30, T8, R3, 40 acres and 60 acres in Sec. 31, T8, T3 (not given precisely). Box 32, file 8.

POLLEY, NANCY - Statement to Court, dated Dec. 4, 1874, by admx. Mary E. Lutes, formerly Mary E. Polley. Mary took out Letters of Adm. to test validity of title to a parcel of real estate (not described) supposed to be in the interest of Nancy Polley's estate. The question was settled adversely. Admx states there are no other assets in Nancy's estate and asks to be discharged. Box 31, file 17.

POLISH, ELIZA - Citation, dated Sept. 5, 1909, served on "Eliza Polish for contempt of Court in failing to make report as such guardian". Eliza Polish was grdn of Laura B. Polish (in Index)/ Lawrence B. Polish (on citation). Eliza was said to "live on Union St. in a nearby city". Box 94, file 2.

\* POOL, LUTHER - Application for Letters of Administration, dated Aug. 9, 1899. Died Feb. 1, 1899, Morgan Co., Ind., intestate. Amanda Griner is appointed admx.; her sureties are Joseph Griner and Edward Griner. Petition, dated Aug. 15, 1899, by Gordon M. Simons, husband of Adaline Simons, living child and heir of Luther Pool. Decedent was a resident of Morgan Co. at the time of his death. Amanda Griner is the wife of Edward Griner, said to be a person of unsound mind. Mr. Simons asks Court to rescind appointment of Amanda Griner as admx of the estate of Luther Pool. Document, dated Sept. 6, 1899, from Central Indiana Hospital for the Insane: Edward Griner is released as recovered. Edward gives his consent for his wife, Amanda Griner, to serve as admx. Final Report dated June 10, 1904: assets equal debts. There are vouchers and claims. (No heirs are named.) Box 86, file 12.

POTTER, EDWARD R. - Application for Letters of Administration, dated Mar. 5, 1888. Died Feb. 29, 1888, Brown Co., Jackson Twp., intestate. Adm. is a son of the decedent, Charles E. Potter. Claim by Minerva Potter for her widow's share of estate. Inventory of Personal Estate and Sale Bill. There are two petitions to sell real estate, land is described. Heirs of dec'd are his widow, Minerva Potter; his children, all over age 21, Charles E. Potter, Wm. I. Potter, Samuel E. Potter, Rebecca J. Patterson & Lorena F. Gaunt; his grandchild, Elsworth Potter, age 20, only child of Sarah E. Potter, dau. of dec'd. Sarah died July 20, 1885. On Jan. 5, 1889 land was sold to Minerva Potter: 2/3 of SE $\frac{1}{4}$ NW $\frac{1}{4}$  and NE $\frac{1}{4}$ SW $\frac{1}{4}$ , both in Sec. 8, T9N, R2E, sold for \$384.00. Minerva already owned 1/3 of described land. Report dated Aug. 19, 1890: Adm. states that estate of Edward R. Potter is insolvent and the Court so declares. Final Report dated April 30, 1892: Widow, Minerva Potter, now Campbell, is awarded the \$22.53 remaining in the estate, added to the \$390.46 she had already rec'd. Her full legal amount due (\$500.00) still cannot be paid. Adm. asks to be discharged. Box 67, file 12.

POULTON, HARRIET - Application for Letters of Administration, dated April 11, 1900. Died April 3, 1890, Brown Co. with a Will which was probated April 21, 1900. Her Will was signed Sept. 2, 1886. Executor to be Wm. W. Stockwell. Terms of Will: everything is left to sister, Martha Poulton. After Martha's death all to be sold and divided equally among all the children of "my brother & sisters except that Isaac T. Poulton shall have \$25.00 more than the others".

PROSSER, JAMES (Cont'd)

more money is due them. Signers of the petition are: Mary M. Parsley, Rebecca J. Turner, Elizabeth D. Hutchinson, James I. Prosser, Sarah A. Neely, John C. Prosser, Louisa Karst and Margaret Banister. Claim by W.D. Greene, for a marble gravestone "to be made like one now at the grave of Margaret Prosser". Bill says "one set of tombstones, \$20.00". A drawing accompanies the order. The tombstones ordered to be delivered to Georgetown, Brown Co. on Dec. 25, 1885. Box 60, file 14 A & B.

PRUITT, WESLEY - Petition, dated Dec. 12, 1921, by Wesley Pruitt who asks the Court to release money (\$30.93) due him. The funds are being held by the County Clerk for Wesley Pruitt who is a minor. Wesley informs Court that the funeral expenses of his mother (unnamed) have not been fully paid. He asks for the money to settle the bill. Box 109, file 6.

PRUITT, WILLIAM S., dec'd - Inventory of Estate Worth \$500.00 or Less, dated April 7, 1906. Widow is Nancy Pruitt; appraisers are Henry W. Copenhaver and Eugene Steel. Land is described. Box 87, file 13.

PRUITT, WORLEY - Petition, dated Dec. 12, 1921, by Worley Pruitt who asks the Court to release money (\$30.93) due him. The funds are being held by the County Clerk for Worley Pruitt who is a minor. He requests payment of the money to help defray funeral expenses of his mother (unnamed). Box 109, file 5.

QUINN, PAUL, dec'd - Inventory of Estate Worth \$500.00 or Less, dated Feb. 19, 1876. Widow is Margaret Quinn; appraisers are John King and John Kirts. Land: N $\frac{1}{2}$ NW $\frac{1}{4}$ , Sec. 17, T9N, R4E, in Brown Co., 80 acres. Box 33, file 6.

RACY, GILEAD - Will dated Feb. 12, 1885, Needmore, Brown Co. Witnesses were Isaac S. Wade and David W. Poling. Terms of Will: to wife, Louisa, all land and appurtenances and all personal property, except enough personal property to be sold to give \$5.00 to each of the children: John, Joseph, Gilead R., Hamilton, Elizabeth, Rebecca, Margaret and the heirs of Eveline D. Will entered Probate on April 23, 1886. Application for Letters of Administration, dated April 23, 1886. Gilead died April 8, 1886, Brown Co., with a Will. Louisa Racy appointed Executrix. Report dated Sept. 24, 1886: all debts have been paid. Estate stands at \$156.95. Final Report dated Nov. 22, 1886. Exec. has paid \$40.00 (\$5.00 each) to County Clerk to distribute to the following heirs as directed by the Will of the dec'd. Exec. does not know the residence of any of the named heirs except for John Racy who lives in Oaktown, Ind. Heirs: "children and grandchildren" - John Racy, Joseph Racy, Gilead R. Racy, Hamilton Racy, Elizabeth Lockmiller, Rebecca Taylor, Margaret Polly/Polley, Elizabeth Wooten. Power of Att'y to George W. Allison by Elizabeth A. Lockmiller of Guthrie Co., Iowa; Power of Att'y to George W. Allison by Rebecca S. Taylor of Crawford Co., Iowa; Power of Att'y to Nelson H. Franklin by John Racy of Knox Co., Ind.; Power of Att'y to Nelson Franklin by Margaret Pauley of Ellettsville, Monroe Co., Ind. Tax Receipt, dated Sept 24, 1886: part of W $\frac{1}{2}$ SW $\frac{1}{4}$  and part of SW $\frac{1}{4}$ SW $\frac{1}{4}$  and South side of W $\frac{1}{2}$ SW $\frac{1}{4}$ , all in Sec. 32, T10, R2, containing .30 acres, 38 acres and 2 $\frac{1}{2}$  acres, respectively. Box 58, file 12.

RAINS, JOSEPHINE - Estate of. Missing file, about 1926. Box 120, file 13.

RAINWATER, ROY - Application for Letters of Guardianship, dated Nov. 26, 1906. Roy is a minor, age 11 and "owner in remainder" of land in Brown Co. He lives in Morgan Co., Ind. William L. Rainwater is appointed his grdn. Land is described and sold to William J. Wallace and his wife, Mary S. Box 94, file 10.

RAINWATER, WILLIAM H. - Inventory of Estate Worth \$500. or Less, dated Oct. 8, 1889. Widow, Minerva A.; appraisers, Ed E. Norman & Robert M. Hamblen. Land is described. Box 62, file 11.

Her heirs are her three daughters: Vivian Miller, 51, of Columbus, Ind.; Ethel McDonald, 45, of Nashville, Ind.; Pauline Franklin, 38, of Indpls. Inventory of Real Estate, Lots 176, 177 and 178, Old Plat of Nashville, Ind., valued at \$2,050.00. Final Report dated Jan. 30, 1933: after payment of debts, \$869.24 remains in the estate which is divided in thirds: one portion to Vivian Miller; one portion to Pauline Franklin and one portion divided among the children/heirs of Ethel McDonald who died while the estate was being administered. Those children are Donna Madge, Kenneth, Carroll and Pauline, all surnamed McDonald. Adm. resigns. Box 370, file 14.
