Will of JAMES C. JOURNEY, deceased

I, James C. Journey of the county of Herry and state of Tennessee, being weak in body, but of sound and perfect mind and may blessed be Almighty God for the same, do make and publish this my last will and testament in manner and form following, that is to say. I give and bequeath unto my beloved wife Elizabeth D. Journey, all my real and personal estate, goods and chattles of what kind and nature soever, consisting of one hundred and sixty odd acres of land whereon I now reside, and one negro girl about sixteen years of age, nine head of horses, nine head of cattle and all my hogs, sheep etc., with all of the household and kitchen furniture and farming utensils of every description during her natural life, and after raising and schooling my children out of the said property, if there should any remain at her death, then to be equally divided amongst my nine children, to wit, James C. Journey, Jane M. Journey, William F. Journey, Mary E. Journey, Reuben S. Journey, John C. Journey, Lewis J. Journey, Cyrus W. Journey, Sarah L. Journey, though it is to be understood that

the first named legatee James C. Journey, having received about one hundred dollars from me, is to have that much less on a final division and thereby appoint my said beloved wife Elizabeth D. Journey and James D. Porter, my Executor and Executrix, with full power and authority to sell any part or parcel of the above named property, real or personal, as they may think most advisable for the purpose of paying all my just debts. This I make my last will and testament, hereby revoking all former wills by me made.

Will of ANN DAVIS, deceased

In the name of God, Amen. I, Ann Davis of Henry county, and state of Tennessee, being sick in body, but of sound and disposing mind and memory, knowing that it is appointed for all men once to die, I therefore think right and proper to dispose of my worldly estate in the following manner. And first of all, it is my will that my body be decently buried and the expenses paid out of my estate by my executor hereinafter to be named. 1st, it is my will and desire that my son Allen Davis have my two beds and furniture and all the furniture of my house and kitchen and the occupant on where I now live, bounded east by Guin's Creek, and bounded west by a fifty acre tract sold to my son Arther Davis and conveyed by him to John Travis, and now in the possession of Mrs. Oneal, and six or seven acres sold to Henry Young, including his buildings and the crop now growing on the said occupant or farm, is to belong to my said son Allen Davis. It is my will and desire that all my just debts be paid, and if my son Allen Davis shall pay or cause the same to be paid, that my Executor deliver to him the fore named property and occupant or otherwise to dispose of so much said property as will pay the same, and that the residue be given over to my son Allen. And lastly, I appoint my friend Benjamin Peeples and my son, Arther Davis, Executors to this my last will and testament. In testimony whereof, I have hereunto set my hand and seal this 6th day of October 1840.
