

Miss Edna HINES [16y] died at her parents, Mr. & Mrs. James HINES home at Yellow Prairie. She was buried in the Methodist Cemetery. She was ill three weeks.

Mrs. Dr. John HILL [38] of Second Creek, died last Sunday of an illness. She leaves a husband and three children, aged 12 –19. The children were by her first husband, Ad HARRIS. He was the brother of T. W. HARRIS and Judd HARRIS. She was buried in Old Caldwell Cemetery.

G. E. MITCHELL of Clay Station killed himself last Sunday with an overdose of morphine.

Capt. W. I. ROGERS, a Naval Veteran of the Confederacy died at Galveston.

Horace HART, a boy died in a team accident at Waverly, Texas.

**JULY 20, 1906** 

A very disastrous wreck occurred on the Beaumont branch of the Santa Fe, 2 miles south of Plantersville last Monday. Two trains ran together at full speed, killing fireman GRIFFIN, of Conroe instantly and fatally scalding engineer Charles SECHRIST.

Rev. W. E. JAMES died at the home of his daughter, Mrs. COFFIELD in Bowie on the 17th instant. He was well known in Burleson County. He was 75 and a native of Wales, where he grew to manhood and married his wife who died only a few months ago. Immediately after their marriage, they sailed for United States, residing in northwest states of the Union for many years and about 1877, removed to Texas and settled near Rockdale. He was called to pastorate of First Baptist Church in Caldwell from 1878 to 1883 and other times as well. He raised a large family, 5 sons and 3 daughters. His sons are, Wade JAMES, Dr. A. JAMES, Judson JAMES, T. O. JAMES and Weyland JAMES, the latter 3 being engaged in stock raising. His oldest daughter married C. H. COFFIELD, the 2<sup>nd</sup> daughter, Clolista JAMES married E. L. OUSLEY and died several years ago. The youngest daughter, Miss Bertha Maye JAMES is unmarried. [see June 29 issue]

Mrs. Elveria STAMPS is reported in critical condition at home of Mrs. A. C. MURRAY, her daughter.

L. H. KILPATRICK left Tuesday for his old home in Kingston, North Carolina to attend the bedside of his father, who has been critical for some time.

**AUGUST 24, 1906** 

James A. HILL, age 63y 2m 19d, died suddenly August 19. He had been a sufferer with rheumatism for several years and had not been in good health lately. He was born in Indiana and came to Burleson County when he was 14 years old. He was a good man, a kind neighbor and had esteem and respect of everyone. He was a Confederate soldier serving most creditably throughout the whole war. He leaves a wife and 2 sons, Hugh HILL and Bennie HILL, of Caldwell and 2 daughters, Mrs. TEAGUE, of Giddings and one brother, Dr. J. T. HILL, of Caldwell. Funeral was at Old Cemetery Monday afternoon.

Fred GARVIN, well known engineer on this division of Santa Fe, dropped dead at the Harvey House in Somerville Monday night while drinking a cup of coffee. Remains were carried to Temple for interment Tuesday.

Sheriff HENSLEE received the reward for Negro Will DAVIS, who was killed in the attempt to capture him.

AUGUST 31, 1906

Mr. McCOWEN was born in Arkansas, but moved to Texas with his parents in 1840, settling in Red River County. He was married in Brenham, Texas in 1853, to Miss

Eliza FERRELL and they came to Burleson County in 1857, since which time he has been a resident. He leaves 7 children living, having been the father of 13, who are John McCOWEN, Miss Mary McCOWEN, Mrs. Ellen WALLACE, Mrs. Emma HADDOX, Mrs. Kate ARMENDT, Mrs. Annie HENSLEE and W. E. McCOWEN. He was a member of the Methodist church and was buried at Masonic Cemetery.

She was born in Meridian, Mississippi, where she was married, came to Burleson County in 1868, having lived here since that time. She leaves 3 daughters, Mrs. A. C. MURRAY, Miss Nora STAMPS, of Caldwell, Mrs. Frank CHRIESMAN, who lives in west Texas, two sons, Will STAMPS and Jeff STAMPS, who also live in that section of the state, one brother, W. M. HESLEP, of Caldwell and one sister, Mrs. D. W. BUCKHOLTS, of Buckholts. She was a member of the Baptist church and was buried at Masonic Cemetery.

#### **SEPTEMBER 21, 1906**

Clarence Wesley BURNS, son of Mr. & Mrs. J. W. BURNS died of congestion at their home in Hookerville, September 13 at the age of 3y 1m 21d. He was the eldest child and was devoted to his little sister. He was buried at Liberty Cemetery.

Mrs. Georgia Anna LAMKIN, 58y 4m 1d, died at her home in Caldwell after an illness extending over 3 months and was confined to her bed 7 weeks. It was some type of tubercular trouble. Mrs. Lampkin was one of the members of famous BROADDUS Colony, which came to Burleson County in 1854, being the granddaughter of Judge Andrew BROADDUS and was born in Caroline County, Virginia. She had lived in Burleson for over half her life and was well known and loved by all with whom she was associated. She leaves one son, Homer and 4 daughters, Mrs. E. P. HUTCHINGS of Marlin, Mrs. Mamie WELBORNE, Mrs. R. Lee JOINER and Miss Lottie LAMKIN of Caldwell. She was a member of Baptist church. Funeral arrangements had not been made at press time.

Judge Alexander William McIVER, 70y 22d, died at his home in Caldwell Monday, September 19. He was slightly ill with bilious trouble, but was not considered serious until Wednesday. The body has been embalmed to await the arrival of his daughter from Louisville, Kentucky. He was born near Jonesboro, North Carolina, where he attained his majority. He spent a short time in Alabama and then came to Georgetown, Texas, where he taught school and afterward taught in what is now Lee County. In 1858 he married Miss Mary Eliza WILSON, the children of this marriage being, J. A. McIVER of Lee County, Mrs. Emma WOODY of Louisville, Kentucky. He then taught school in Dewitt County and law school at Brenham, Texas where he secured his license and joined the Confederate army, serving throughout the war. In 1886, he and family settled in Caldwell, where he was elected County Judge and served until reconstruction era put him out of office. He has been engaged in act of practicing law here since. He married the second time in July 1882 to Miss Julia E. HARRIS, who survives him with one daughter, Miss Julia McIVER. He was a member of Board of Trustees of Baylor College at Belton for many years. He was also a member of Board of Managers of the Confederate Home [Austin]. He was a Baptist.

Mrs. Martha HOLLOWAY MASON LONGWELL was born in Culpeper Co., Virginia on December 17, 1822

Order of the State of Texas. The are 71 lodges in the state and Caldwell was host to a 3-day convention.

# **JULY 5, 1907**

C. J. HENDERSON, brakeman on the Beaumont division of Santa Fe, was horribly mangled and killed by a switch engine late Tuesday afternoon. He had just been given the day off to go to his home in Palestine and he and another man were scuffling, when he fell on track in front of an engine, the wheels cutting him in two. The remains were carried to the young man's home under the auspices of the Brotherhood of Locomotive Fireman.

John W. WOOD died at Haskell, Texas, June 30. He was born in Barber County, Alabama on December 23, 1859, came to Texas in 1875 and settled in Burleson County where he was raised. He suffered with consumption. He leaves one brother, M. W. WOOD, of near Caldwell, 3 sisters, Mrs. P. G. JOHNSTON, of Chriesman, Mrs. B. F. CROUCH, of Marlin, Mrs. F. BOWEN, of San Antonio. Remains were laid to rest in cemetery at Haskell.

F. M. MUNDINE died at his residence in Lexington, Lee County last Friday evening at age of about 70. He was stricken with paralysis several years ago and he had another stroke again last Monday while at Austin and from this stroke he died. He has been a prominent personage in Burleson and Lee Counties for the past 50 years. He was always an active man in political affairs and at one session of the legislature, several years ago, he was representative from this and Lee County.

### **JULY 12, 1907**

After short illness with acute bronchitis, Mrs. Earlie HILL, wife of Dr. J. T. HILL died at their home on Second Creek Tuesday night. Her remains were tenderly laid to rest at Masonic Cemetery. She was born in 1871 in Gonzales County and therefore was in her 36th year. She resided in Burleson County for many years and leaves her husband and 2 children, the youngest, a baby only a few days old. She was a member of the Christian church.

Will Chiles WOMBLE drowned at Port Arthur late Sunday afternoon. His brother, Drew who was here from Dayton, Ohio left on the 1<sup>st</sup> train to bring remains home. He was engaged in the photograph business at Port Arthur since last February and died there from heart failure July 7. At the time of death he was bathing in water about 4 feet deep with two ladies, Mrs. Henry MOORE and her sister, Caryl AUBREY, of Cameron, Texas, daughters of Capt. T. J. AUBREY, formerly of this county. Mr. WOMBLE was playing and joking in the water with the younger sister, when he did not come up. Two physicians said death was due to his heart, because he had no water in his lungs. He was born Dec. 10, 1874 and was buried at Old Cemetery. His brothers, Judson WOMBLE and Drew WOMBLE and Mrs. MOORE accompanied the body here.

J. C. THOMAS died at his home here Saturday morning of dropsy. He was born in Georgia about 64 years ago moved to this county about 35 years ago. He leaves a wife, 6 sons and 4 daughters, besides other relatives to mourn his death. Burial was in Providence Cemetery. [Volney]

# **AUGUST 16, 1907**

The most shocking tragedy ever enacted on Edward's Prairie occurred near home of Frank MAREK Wednesday before noon, when his daughter, Rosie MAREK blew the top of her head off with a single barreled shotgun. She was only 17 and was the oldest daughter. Her parents, sister and several brothers survive her. Earlier she had been helping her mother with the washing. No real motive was known, except perhaps a love affair. She was laid to rest at family burying grounds at New Tabor.

Mrs. Mary BRAVENEC died at her home 3 miles north of town Tuesday afternoon in the 69 year of her age. She left two grown children, her husband dying about 22 years ago. She was buried in the family burying grounds at New Tabor.

Winston JOHNSTON [c] killed his wife several weeks ago and is in the county jail.

#### **AUGUST 23, 1907**

Nick WILLIAMS [c] died from damp air in a well Tuesday at A. POLLOCK's place near Cook's Point. Mr. POLLOCK tried to get him out, but he was so overcome, he could not hold on.

Remains of Charlie SCHLECK were brought here from Austin yesterday and interred in Old Cemetery. He was 45. His mind was affected and he had been judged insane and sent to asylum at Austin where he remained until his death Wednesday. A wife and several children survive him

# **AUGUST 30, 1907**

Mrs. Louisa SCHRADER died at her home in New York last week in her 74<sup>th</sup> year of her age. She leaves 4 children, Mrs. Minnie HARTH, Mrs. Jennie OSBURG and Frank SCHRADER, all of New York and Frank SCHRADER, of this place. [Two Franks?]

#### **SEPTEMBER 6, 1907**

C. P. HILL died at his home on Second Creek late Tuesday afternoon, after a lingering illness. He was 40 and the son of Dr. J. T. HILL, of that community. He leaves a wife and 4 children to mourn. He was a member of Baptist church and a member of Lyons Camp of Woodmen of the World. He was buried at Masonic Cemetery.

#### **SEPTEMBER 13, 1907**

Rev. W. E. McCLENNAN died at home of his son-in-law, John R. LYON at Lyons last Friday morning in 61st year of his age. Several weeks ago he received a fall while working on a house and never fully recovered from it. He was a native of Alabama, an active member of Methodist church and had been married twice. The first time to Miss MAYFIELD and to them were born several children of whom 3 now survive, Mrs. J. R. LYON and Will McCLENNAN, of Lyons and Mrs. G. D. WILLIAMS, of Caldwell. Several years after demise of 1st wife, he married Miss Imogene ROBERTS, who died about 3 years ago. No children were born to this marriage. He was a prominent Mason, founded Lee Scott Lodge, of Lyons and was Master of this lodge at time of his death. The remains were shipped to Round Rock and laid to rest with Masonic honors.

Dee EARTHMAN died at family home in Conroe last Saturday at age of 30 and was laid to rest in cemetery here the next day. He was single and a brother to Mrs. H. C. CLARK of this place.

M. S. HEWITT, of Georgetown came down Thursday to attend funeral and burial of A. E. McARTHUR.

James Calvin HALE died at his home on Tuesday morning and was buried in Masonic Cemetery with Masonic honors. He was born at Bolivar, Polk County, Missouri, November 4, 1836 and there was raised and spent early life. In 1853, he moved to Texas where he met and won his life's companion, Miss Eliza SMITH, they being married in 1845. Soon after they moved to Gay Hill in Washington County. When the Civil War broke out, Mr. HALE joined the volunteers and served as soldier for awhile, then joined the Cavalry in which he served till close of war. After the hostilities ended he and his family moved to Deanville and farmed until about 1886, when they moved to Caldwell. Early in life, he joined the Baptist church. Since 1886 he had been manager of Hale's platform and is known to all farmers in the county. He leaves a wife and grown children, Mrs. M. E. CAPPS, of San Bernadino, California, Mrs. Cyrus HOPE, of Ft Stockton, Texas, J. C. HALE, of Houston and 17 grandchildren and 5 great grandchildren.

# **BURLESON COUNTY LEDGER**

The issues of the new paper have the date on the front page and do <u>not</u> have any dates or page numbers on the following pages. This makes it very difficult to tell when the event has happened, especially if the pages are loose, mixed up or torn, as are the issues of 1912, and if there is not a reference to a date somewhere on the page. Several articles, perhaps obituaries have been cut out of paper. Please take all of this into consideration when reading the items. **Some dates can not be verified in 1912 issues**. There were very few births listed in this year's paper.

# **JANUARY 5, 1912**

Deputy Sheriff E. A. ELLIS returned Tuesday evening from Somerville where he had been called to investigate the finding of a dead infant. On Monday night the car sweeper found a female infant, neatly wrapped in a **Beaumont Enterprise** of the issue December 31, 1911 and packed in a cheroot box, which was under the seat of the car. This train from Beaumont arrived in Somerville at 11:45 p.m. and it was 3 o'clock when the car sweeper found the box. Deputies ELLIS and Sledge HOUSTON buried the little body Wednesday and are working at this end of the line to find guilty parties, while officers at Beaumont are working at their end of the road. Officers say they have good clues to work on.

Dr. J. T. HILL died at his home on Second Creek Tue. evening at the age of 67y 6m 26d. Remains were buried at Masonic Cemetery. He was born in IL, but came to TX with parents when quite small and for many years had made his home where he died. For past 45 years he had been a faithful and consistent member of Baptist church. The following children survive Ed, John and Tony HILL and Misses Elna HILL and Ruth HILL.

Henry SMITH, a colored man living between Cooks Point and old river was found Sunday frozen to death. He lived right near there and was found not a great way from his home.

All parties holding claims against the estate of Mrs. A. E. McARTHUR, deceased will prove up their claims according to law and file them.

The old gray horse belonging to Mrs. Sudie HUDSON died Saturday morning at age of about 35 years.

Jack SPATT, little infant died Sunday and was buried at Chriesman Cemetery on Monday.

# **JUNE 4, 1915**

Hon. J. R. HESLEP, of this city who died in Austin Sanitarium Tuesday arrived here on the Tango. [train] Burial was at the Masonic Cemetery under the auspices of Knights of Pythias and Woodmen of the World. One of the largest corteges in attendance at funeral and burial that has been seen at a funeral here. Born February 4, 1867, reared and educated here, admitted to the bar, May 24, 1892, elected City Attorney soon after. Some time later was elected to legislature where he served two terms. He was a Methodist. On December 12, 1894 he married Miss Adline KNOX of Navasota, who survives him, along with two daughters; Misses Queen HESLEPand Bessie HESLEP.

Joe BEHNE, age 14, blue eyes, light hair, small for age, upper teeth large, lower small, had on striped overalls and new black buttoned shoes. Supposed to have been drowned on night of April 20, 1915. Will pay \$100 reward for his body, dead or alive. Albert BEHNE, Rosebud, Texas.

<u>BORN</u>: Two-headed calf born in Somerville. It died and was embalmed by undertaker SCHILLER, so it could be displayed.

#### **JUNE 11, 1915**

Mrs. Anna GOLD CHALOUPKA, wife of Joe CHALOUPKA were shipped from San Antonio Friday and buried at New Tabor Cemetery Saturday. She had been in bad health for some time and this brought on insanity: She was sent to asylum for the insane and had not been there very long when she hanged herself with a window curtain. She was a good and industrious woman before her affliction. Her husband and several children survive.

"Aunt Francis" CARPENTER, a good old colored woman about 72 years old died at her home in Freedman town Tuesday night.

Aunt Joanna CONWAY [c] died a few days since and was buried at Brewers Hill Cemetery Friday.

#### **JUNE 18, 1915**

The seven-month-old daughter of F. B. LAMBRECHT died at their home Sat. and was buried at Birch Sunday.

Ed F. WILLIAMS died at home of his father, William WILLIAMS near Hix Friday from typhoid. Remains were buried at Hix. He was 27 and unmarried.

# **JUNE 25, 1915**
