524. JOHN HUDSPETH enters 640 acres of land in Surry Co. on both sides of the S fork of DEEP CREEK joining his own entry of land including the improvement that FREDRICK LONG now lives on - August 12, 1778. [Warrant granted. April 26, 1779 - caveated by FREDRICK LONG, returned to court, entry withdrew and money refunded.]
525. RICHARD GENTRY enters 200 acres of land in Surry Co. on the S side of the YADKIN RIVER beginning at a marked red oak on the bank of the river and joining CHARLES DUDLEYS entry and running down the river to JOHN GARROTTS entry for quantity - August 12, 1778. [Warrant granted to H. S.]
526. ALLEN GENTRY enters 200 acres of land in Surry Co. on the N side of the YADKIN including my improvement for complement - August 12, 1778. [Warrant granted to R. LANIER.]
527. ROBERT SEXTON enters 100 acres of land in Surry Co. on both sides of BIG BEAVER CREEK including my plantation for complement beginning at BAKER'S tract and running up the creek - August 12, 1778. [Warrant granted to R. LANIER.]
528. MARTIN BRIDGEFARMER enters 50 acres of land in Surry Co. joining the YADKIN RIVER on the one side and ROWAN LINE on the other including my improvement for complement - August 12, 1778. [Warrant granted to H. S.]
529. JOSEPH COKER enters 200 acres of land in Surry Co. on BIGG BEAN SHOLE CREEK including my improvement for complement - August 12, 1778. [Warrant granted to H. S.]
530. BARNED DEMSEY enters 200 acres of land in Surry Co. on FISHERS RIVER beginning about 200 yards of a shole known as BUCK SHOLE, then running S, then E, then N and then W to the first bounds - August 12, 1778. Warrant granted to J. M.]
- [531. MICHAEL RONNALDS enters 100 acres of land in Surry Co. on HOGINS CREEK beginning at a marked chestnut tree on the said creek above the WIDDOW RAINWARTERS then up the said creek on both sides including the improvement whereon CHARLES ROULAND formerly lived - August 12, 1778. [Warrant granted to H. S.]
532. JOHN HIEST (HEIST) enters 200 acres of land in Surry Co. on the DOUBLE CREEK joining ROBERT LANOIR'S agent tract the N side of the YADKIN RIVER including my own improvement - August 1778 (no day given). [Warrant granted to W. T.]
533. JOHN CROME enters 200 acres of land in Surry Co. on a branch called "TOMEHOCK" (TOMAHAWK) BRANCH on both sides - August 12, 1778. [Warrant granted to W. T.]
- [534. JAMES RAINWARTERS (RAINWATERS) enters 200 acres of land in Surry Co. on HOGINS CREEK where the WIDDOW RAINWARTERS now lives on both sides of the said creek for complement - August 12, 1778. [Warrant granted to H. S.]

33. ROBERT COKER enters 400 acres of land in Surry Co. on TOMS CREEK including his improvement whereon he now lives where the road from the Moravians crosses said creek to the Hollow - November 12, 1778. [Warrant granted to T. COKER]
4. JOHN LANKFORD enters 350 acres of land in Surry Co. beginning at a white oak tree marked "I. L." on the E side of PETERS CREEK including his plantation and crossing some of the branches of ELK CREEK and DAN RIVER running agreeable to Act of Assembly - November 12, 1778. [Warrant granted to C. M.]
5. JOSEPH CLOUD, JUNR. enters 60 acres of land in Surry Co. beginning on a beach tree marked "I. C." or "I. C."(?) a division agreed upon between STEPHEN FIELD and JOSEPH CLOUD including the vacant land between an old survey now in dispute between said CLOUD and JNO. LEMON and STEPHEN FIELD - November 12, 1778. [Warrant granted to C. M.]
6. EDMOND HODGES enters 400 acres of land in Surry Co. on both sides of FISHES RIVER beginning at a ford on the said river between JOHN CARTER and myself then running agreeable to Act of Assembly - November 12, 1778. [Warrant granted]
7. SAMUEL HAGGARD enters 200 acres of land in Surry Co. on the head of BOONS CREEK including his own improvement - November 12, 1778. [Warrant granted to R. D.]
8. WILLIAM HEAD enters 200 acres of land in Surry Co. above WILLIAM ROBINSON'S on the S fork of DILLS CREEK including the improvement of GEORGE HEAD - November 12, 1778. [Warrant granted to H. S.]
9. MATTHEW MOORE enters 150 acres of land in Surry Co. on BUCK ISLAND CREEK including AMOS EVANS' plantation running agreeable to law - November 12, 1778. [Warrant granted]
0. THOMAS SPENCE enters 200 acres of vacant land in Surry Co. on FALL CREEK adjoining my line and SAML. HAINS' line - November 12, 1778. [Warrant granted to R. L.]
1. SILVANAS PIPES enters 150 acres of land in Surry Co. on the BIGG ELKIN including my improvement for complement - November 12, 1778. [Warrant granted to J. M.]
2. JOHN HORN enters 150 acres of land in Surry Co. on BRYSELS CREEK including my improvement for complement - November 12, 1778. [Warrant granted]
3. JOHN BRASSEL enters 400 acres of land in Surry Co. on both sides the BEAVER DAM CREEK including my improvement for complement - November 12, 1778. [Warrant granted]
4. JAMES RAINWATERS enters 200 acres of land in Surry Co. on FISHES RIVER adjoining JOHN JARVIS including my improvement for complement - November 12, 1778. [Warrant granted]
