It being made <u>appear</u> to this court that JAMES RAINWATER in EDWARDS' DISTRICT is taxed with two polls for the year 1792 more than he had a right to be taxed with, agreeable to law, therefor is released from the payment of the same &c.

The depositions of WM T LEWIS and AIRS HUDSPEATH, taken before STEPHEN WOOD Esquire was proved by the oath of said WOOD and ordered to be recorded. AIRS HUDSPEATH to pay 2/.

THOMAS HINSHAW is app't overseer of the road in the room of ELISHA JOHNSON.

Ordered that JOHN WILLIAMS be released from the payment of the tax of his negro fellow called VENTURE for the future.

JOHN PARSONS SENR is app't overseer of the IRON WORK ROAD from THOS SPENCES, to CAPT AYRES HUDSPEATH'S MILL and all the hands convenient work thereon.

A deed from THOMAS HUDSPEATH to JAMES LOCKET was acknowledged in open court and ordered to be registered. 6/paid.

An inventory of the estate of MATTHEW CREED was returned by JOHN CREED admr. and ordered to be recorded, and an order of sale to issue. no fee paid now. 4/paid by CAPT KINKANNON.

DRURY MCGEHEE is app't overseer of the road in the room of JOHN CREED.
