Ordered that Administration on the Estate of John VINSON Decd. be granted to Aaron VINSON Esqr. who entered into Bond with William WARD and John BRYAN Esqr. Securities in the sum of Five Thousand Pounds for the faithful discharge of his duty, and Qualified.

Ordered that John LEE on Marks Creek be exempt from paying a poll Tax by Reason of his Age & Bodily Infirmary.

Ordered that James BUTLER be exempt from paying a Poll Tax on Acct. of his Age & Bodily Infirmary.

Ordered that Samuel SMITH Averitt PEARCE & John MCCULLERS esquires be appointed to Settle the Estate of Elias GEORGE decd. with the Exers. &c.

Ordered that Moses JOHNSTON be allowed Thirty two Shillings for warning for warning the Inhabitants to give in their lists of Taxble property for the Year 1785 & 1786.

Ordered that Jacob & William WALKER be exempt from paying paying poll Taxes for the present Year being Under age when they gave in their lists.

Ordered that Jesse WOOTTEN who formerly worked on the Road under Lewis BRYAN, work under Samuel WILDER.

Ordered that John GULLEY be appointed Overseer of the River on the South Side from Edward BLURTONS District to MCCULLERS Old Road leading to to SMITHS Ferry by Etheldread GREGORYS.

Ordered that John HINTON be appointed overseer of the River on the South side from John GULLEYS district to the line of Wake County.

Ordered that Freeman KILLINGWORTH be appointed of Overseer of the River on the North Side from Edward BLURTONS District to Jesse WOOTTENS Mill Path leading to Robert GULLEYS from thence with the Road to SMITHS Ferry.

Ordered that Isaac HINTON be overseer of the River on the North Side from Freeman KILLINGSWORTHS District to the line of Wake County.

Ordered that the following Deeds be Registered (to wit)

Leonard MUSSLEWHITE to Richard WARREN proved by Joseph INGRAM.

William PUGH to Tignal PUGH acknowledged.

Court Adjourned til Tomorrow Eight OClock.
