Reedy Br; paid £5.0 "Dr." 1/2; warrant issued [to] Jno Sullivant.

794 (150). Aug. 23, 1778 Isaac Deane enters 500 ac; border: Thomas Tillery decd, Thomas Hill, William Pully, Thomas Deane, & on S side of Connaway Cr; paid £13.6; warrant issued.

795 (151). Aug. 23, 1778 William Brinkley enters 390 ac; border: his own land and William Brinkley sr; paid £10.11; caveated by No. 165 Thomas Charles Bradberry and bond filed; this caveat dismissed by Court order Feb. term 1793; warrant issued Mar. 29.

796 (152). Aug. 25, 1778 William Killingsworth enters 100 ac; border: the mouth of Primus [or Primer] Br, John Killingsworth's line, runs up the branch to the mouth of Hogpen Br, up said branch to the head, on John Killingsworth's line, & "his" line to the beginning; £3.6; warrant issued [to] Jno Sullivant.

797 (153). Sept. 7, 1778 Robert Pasmore enters 100 ac; border: his own land, Goodorum Davis, Thomas Hill, David Marshall, & "no" water course; paid £3.6; warrant issued.

798 (154). Sept. 11, 1778 Henry Montfort enters 100 ac; border: Patty Williams, Crocken, Sarah Wood, & William Green; paid £3.6; warrant issued.

799 (155). Sept. 16, 1778 William Taylor enters 80 ac; border: Haming Tumbley, Jennings, hachny decd, & his own land; paid £2.16; warrant issued; claim withdrawn and money returned.

800 (156). Sept. 18, 1778 James Adams enters 200 ac; border: at 3 possimmons in Pine Br at a tar kiln, runs to a black jack, along the dividing line between Nathanl. Merritt and Richard Barden to two white oaks and a red oak on the head of [the] dividing branch between said Merritt and William Rainwater, with said branch to a possimmon corner, to a hickory and red oak, with said line to an ash on Rainwater Br, up the branch to an ash on lower side of said branch, with said line to a red oak corner, to Rainwater's corner pine, with said line to a red and white oak on Chochutto Cr, up the creek to the mouth of Pine Br, & up the branch to the beginning; paid £5.16; warrant issued to said Adams.

801 (157). Sept. 19, 1778 John Wooten enters 640 ac; border: his own line, Elisha Pitman, Egbert Haywood, William Lane, & "no" water course; paid £16.16; warrant issued Feb. 4, 1779.

802 (158). Sept. 19, 1778 Frederick Jones enters 640 ac; border: Richard Whitaker, Cary Whitaker, Elisha Pitman, Robert Ward, & Benjamin Rowell; paid £16.16; warrant issued Feb. 4, 1779.

803 (159). Sept. 19, 1778 John Bradford enters 640 ac; border: his own land,
