✕ **Rainwater, Leander**—Private Feb. 16, 1861. Transferred to Co. I, Oct. 1, 1861. Killed at 2d Manassas, Va. Aug. 30, 1862.

Ralls, Charles H. (or Rolls)—Private Feb. 21, 1861. Captured Sept. 5, 1862. Transferred to Aiken's Landing, Va. for exchange Sept. 27, 1862. Exchanged Nov. 10, 1862. No later record.

Rees, Henry F.—See 3d Corporal Co. I.

Sinnone, George W. (or Symons)—Private Feb. 27, 1861. Roll for June 30, 1864, last on file, shows him present.

Smith, Edward—Private Mar. 15, 1861. Appears last on roll for Oct. 30, 1861.

Smith, James V.—Private Mar. 2, 1861. Roll for June 30, 1864, last on file, shows him present.

Stewart, Montgomery—Private Apr. 27, 1861. Appears last on roll for Dec. 30, 1863.

Sullivan, B.—Private Feb. 24, 1861. Appears last on roll for Oct. 30, 1861.

Wade, John Daniel—Private. Made application on Apr. 1, 1865 to appear before a Medical Board for examination for the position of Asst. Surgeon in P. A. C. S. The Asst. Surgeon of the regiment stated that John Daniel Wade was acting as Hospital Steward of the organization named for 6 months and frequently performed the duty of Asst. Surgeon. Application was approved Apr. 6, 1865, but no record has been found to show date of his appointment. Surrendered, Greensboro, N. C. Apr. 26, 1865.

Walls, J. L. F.—Private Feb. 27, 1861. Appears last on roll for Oct. 30, 1861.

Watkins, James—Private Feb. 28, 1861. Appears last on roll for Oct. 30, 1861.

Webb, John J.—Private Feb. 21, 1861. Appointed Sergeant. Wounded Mar. 20, 1863. Absent, wounded, Dec. 30, 1863. No later record.

Williams, John H.—Private Feb. 21, 1861. Wounded and captured at Sharpsburg, Md. Sept. 17, 1862. Died of wounds at Smith's Farm.

Wilson, George W.—Private Mar. 11, 1861. Transferred to Co. D, and appointed 5th Sergeant June 25, 1861. Retransferred to Co. C, July 17, 1861. Appears last on roll for Oct. 30, 1861.

Mathews, Harris—Private May 11, 1861. Wounded at 2d Manassas, Va. Aug. 30, 1862. Appointed Corporal. Surrendered, Greensboro, N. C. Apr. 26, 1865.

McGlamery, George W.—Private Mar. 25, 1861. Killed at John's Island, S. C. July 7, 1864.

McIntyre, John—Private Mar. 11, 1861. Wounded and captured in 1862. Exchanged. Surrendered, Greensboro, N. C. Apr. 26, 1865.

Moody, John—Private Apr. 13, 1861. Died at Savannah, Ga. in 1861 or 1862.

Moore, J. T.—Private Feb. 19, 1864. Roll for June 30, 1864, last on file, shows him present. No later record.

Morahan, Patrick—Private Mar. 23, 1861. Appointed 4th Sergeant. Killed in South Carolina in 1865.

Murphey, Thomas A.—Private June 19, 1861. Wounded in 1864. Sent to Augusta, Ga. hospital July 20, 1864. No later record. Born in Jefferson County, Ga. Dec. 24, 1832.

New, Jesse M.—Private Mar. 29, 1861. Killed at 2d Manassas, Va. Aug. 30, 1862.

Nicholson, Jason—Private Mar. 23, 1861. Transferred to Co. G, in 1861. Died of fever at Camp Walker, near Manassas Junction, V., Aug. 18, 1861.

O'Farrell, Ed—Private 1864.

O'Neil, John—Private Mar. 7, 1861. Captured in Savannah, Ga. hospital Dec. 21, 1864. Died of chronic diarrhoea, in 20th Army Corps Hospital at Savannah, Ga. Jan. 26, 1865.

Parish, John—Private Feb. 26, 1861. Surrendered, Greensboro, N. C. Apr. 26, 1865.

Parrott, William—Private Mar. 21, 1861. Appears last on roll for Oct. 31, 1861.

Pittman, Atlas—Private Apr. 13, 1861. Roll for June 30, 1864, last on file, shows him present. No later record.

Pool, Silas—Private Feb. 3, 1864. Roll for June 30, 1864, last on file, shows him present. No later record.

Powell, James W.—Private Mar. 18, 1861. Transferred to Co. E. Captured at Sheffield, Ga. July 22, 1864. Died of diarrhoea at Camp Chase, O. May 20, 1865. Grave #1988, Camp Chase Confederate Cemetery.

Payne, John T.—Private Sept. 24, 1862. Killed, Manassas Gap, Va. July 23, 1863.

Payne, Ramon P.—Private. Killed, Manassas Gap, Va. July 23, 1863.

Payne, Urias M.—Private Sept. 24, 1862. On sick furlough Oct. 31, 1864. No later record.

Payne, William M.—Private June 27, 1861. Died, typhoid fever, C. S. General Hospital, Danville, Va. Oct. 7, 1864.

Pearman, William—Private June 27, 1861. Died, Richmond, Va. July 17, 1862.

Peeler, William H.—Private. Discharged 1862.

Perry, Joel Walter Jr.—Private Apr. 24, 1861. Wounded, South Mills, N. C. Apr. 19, 1862. Transferred to Co. K, 1862. Appointed 1st Lieutenant and Adjutant this regiment Aug. 6, 1862. Wounded, Sharpsburg, Md. Sept. 17, 1862. Died, wounds, Sept. 19, 1862.

Phelps, Ansel B.—Private Apr. 24, 1861. Discharged, underage, Oct. 1861.

Pippin, Needham—Private Apr. 26, 1861. Wounded, Crater near Petersburg, Va. July 30, 1864. Surrendered, Appomattox, Va. Apr. 9, 1865.

Ponder, A. (or Pounder)—Private Apr. 26, 1861. Discharged 1864.

Powell, Edward S.—Private Nov. 5, 1862. Surrendered, Appomattox, Va. Apr. 9, 1865.

Raden, D.—Private Apr. 24, 1861. Transferred to Co. K, 44th Regt. Ga. Inf. May 2, 1862. Killed, Chancellorsville, Va. May 3, 1863.

Raden, George—Private Apr. 24, 1861. Died, disease, Dec. 1861.

Raden, Richard S.—Private Apr. 24, 1861. Died, disease, July 1862.
