Richmond, Va., with typhoid fever, Aug. 4, 1862, and died there Aug. 7, 1862.

Miller, John (or Jack)—Private Mar. 24, 1862. Paroled at Office of the Provost Marshal General, Army of Potomac, camp near Falmouth, Va. Dec. 14, 1862. No later record. (Born in Walton County, Ga. Dec. 4, 1827.)

Morris, J. C.—Private June 13, 1861. On daily duty as teamster Sept. 1861.

Nixon, Joseph J.—Private Mar. 24, 1862. Surrendered, Greensboro, N. C. Apr. 26, 1865.

Owens, H. A.—Private July 15, 1861. Received pay Nov. 1, 1862. No later record.

Patman, W. C. (or W. E.)—Private June 11, 1861. Furloughed for 40 days Mar. 13, 1863. No later record.

Pierce, F. M. (or Pearce)—Private June 26, 1861. Clothing was issued to him May 23, 1864. No later record.

Powell, H. J.—Private June 11, 1861. Elected Jr. 2d Lieutenant June 15, 1863. Wounded in 1864. In General Hospital #4, at Richmond, Va., with gangrene from wound in left side, in 1864. Furloughed for 30 days Aug. 25, 1864. Discharged, disability, prior to Nov. 1864.

Pritchard, B. W.—Private 1863.

Pruett, George W.—Private June 11, 1861. Admitted to Chimborazo Hospital #3, at Richmond, Va. Apr. 10, 1862. Died of chronic diarrhoea, in General Hospital at Danville, Va., June 26, 1862.

Pruett, J. W.—Private Aug. 1, 1861. Admitted to Danville, Va. hospital, with typhoid fever, Dec. 31, 1861. Sent to Richmond, Va., where he died Feb. 16, 1862.

Rainey, R. E.—Private June 11, 1861. Discharged, disability. Sept. 9, 1861.

Rainey, T. F.—Private June 11, 1861. Admitted to C. S. A. General Hospital at Danville, Va. May 23, 1864, and deserted May 30, 1864.

* **Rainwater, G. W.**—Private. Captured Dec. 12, 1864. Took oath of allegiance to U. S. Govt. at Bermuda Hundred, Va. Dec. 12, 1864. Received by Provost Marshal General at Washington, D.C. and furnished transportation to Philadelphia, Pa., Dec. 15, 1864.

Randall, C. W.—Private June 11, 1861. Died of typhoid fever in Virginia Sept. 20, 1861. Buried in Confederate Cemetery at Lynchburg, Va. No. 6, 3d Line, Lot 159 - College.

Renfrow, A. W.—Private June 11, 1861.

Renfrow, John MacDonald—Private June 11, 1861. Captured "at Dists. Hoke's Div." July 4, 1864. Released at Hart's Island. N. Y. June 15, 1865.

Smith, A. B.—Private June 11, 1861. Appointed Sergeant. Elected 2d Lieutenant Dec. 20, 1864. Unofficial records show he

Manassas, Va. Aug. 28, 1862. Appointed 5th Sergeant in 1863. Deserted near Salem, Va. June 28, 1864. Imprisoned at Knoxville, Tenn., a Confederate deserter, Aug. 3, 1864. Took oath of allegiance to U. S. Government at Louisville, Ky. and released Aug. 27, 1864.

Morrow, William—Private June 24, 1861. Absent with leave July 2, 1861. No later record.

Mullen, James E. (or Mullin)—Private June 24, 1861. Appointed 3d Sergeant. Surrendered, Appomattox, Va. Apr. 9, 1865.

Nix, James—Private Jan. 1, 1862. Substitute for Algernon S. Graves. Appointed 1st Corporal Aug. 8, 1862. Wounded at Sharpsburg, Md. Sept. 17, 1862. Died in Staunton, Va. hospital prior to Aug. 1864.

Phipps, Andrew C.—Private June 24, 1861. Discharged in 1861.

Pyle, Charles H.—Private June 24, 1861. Wounded at 2d Manassas, Va. Aug. 28, 1862. Surrendered, Appomattox, Va. Apr. 9, 1865.

Pyle, George W.—Private June 24, 1861. Wounded at Winchester, Va. May 25, 1862. Roll for Aug. 31, 1864, last on file. shows him present. No later record.

Pyle, John L.—Private June 24, 1861. Discharged, disability. at Manassas, Va. Feb. 1, 1862.

* **Rainwater, James P.**—Private Feb. 20, 1862. Died of disease at Richmond, Va. Apr. 8, 1862.

* **Rainwater, Umphrey P.**—Private June 24, 1861. Wounded at 2d Manassas, Va. Aug. 28, 1862. Wounded Aug. 21, 1864. In Mount Jackson, Va. hospital, wounded, Aug. 31, 1864. No later record.

Rawls, Francis W. (or Ralls)—Private Aug. 7, 1861. Roll for Aug. 31, 1864, last on file, shows him present. Discharged on account of tuberculosis contracted in service, Aug. 1864. Died at home in 1864.

Reid, Andrew A. (or Reed)—Private June 24, 1861. Discharged at Lynchburg, Va. hospital Dec. 1861.

Self, Hayne—Private June 24, 1861. Discharged in 1861.

Shockley, William—Private June 24, 1861. Absent with leave July 2, 1861. No later record.

Shores, Abner P.—Private Feb. 20, 1862. Died of acute bronchitis in Richmond, Va. hospital Apr. 26, 1862.

Shores, A. A.—Private Feb. 20, 1862. Captured at Winchester, Va. July 21, 1864. Released at Camp Chase, O. May 15, 1865.

Shores, J. A.—Private Feb. 20, 1862. Killed at Chancellorsville, Va. May 3, 1863.

Sloan, William C.—Private July 23, 1861. Discharged, disability. at Richmond, Va. Aug. 4, 1862.

Smith, Marshall L.—Private June 24, 1861. Captured at Winchester, Va. Sept. 19, 1864. Paroled at Point Lookout, Md. and

Payne, Elias B.—Private June 21, 1862. Died of smallpox in Camp Winder Hospital at Richmond, Va. Nov. 22, 1862.

Pilgrim, L. L.—Private Aug. 31, 1861. Killed at King's School House, Va. June 25, 1862.

* **Rainwater, David T.**—Private Sept. 7, 1863. Roll for Feb. 28, 1865, last on file, shows him absent without leave. No later record.

* **Rainwater, Virgil C.**—Private Aug. 31, 1861. Captured near Petersburg, Va. June 24, 1864. Exchanged at Boulware & Cox's Wharves, James River, Va. Mar. 16, 1865. No later record.

* **Rainwater, William P.**—Private Feb. 21, 1862. Surrendered, Appomattox, Va. Apr. 9, 1865.

Robertson, F. M.—Private Sept. 26, 1862. Appears last on roll for Dec. 31, 1863.

Robertson, James C.—Private Nov. 12, 1862. Surrendered, Appomattox, Va. Apr. 9, 1865.

Robertson, William B.—Private Sept. 16, 1861. Captured at Gettysburg, Pa. July 2, 1863. Paroled at Point Lookout, Md. Feb. 18, 1865. Exchanged at James River, Va. Feb. 20-21, 1865. No later record.

Robertson, Willis M.—Private May 8, 1863. Sick in hospital Nov.-Dec. 1863. Died of disease in Walton County, Ga. Feb. 1864.

Robinson, Warren Y.—Private Apr. 12, 1862. Wounded at Sharpsburg, Md. Sept. 17, 1862. Severely wounded through right thigh and captured at Gettysburg, Pa. July 2, 1863. Admitted to U. S. A. General Hospital, West's Bldgs. Baltimore, Md., July 29, 1863. Transferred to Provost Marshal General Dec. 2, 1863. Roll for Feb. 28, 1865, last on file, shows him absent without leave. No later record.

Roe, Richard (or Rowe)—Private Aug. 31, 1861. Died at Richmond, Va. Oct. 17, 1864. Buried there in Hollywood Cemetery.

Rucker, George M.—Private Apr. 18, 1864. Wounded at Deep Bottom, Va. Aug. 16, 1864. Roll for Feb. 28, 1865, last on file, shows him absent without leave. No later record.

Rucker, John—Private Aug. 31, 1861. Wounded and disabled at Seven Pines, Va. May 31, 1862. On detached duty at Richmond, Va. in 1863; Enrolling Officer in Cherokee County, Ga. from 1863 to June 1864. Roll for Feb. 28, 1865, last on file, shows him absent without leave. Pension records show he was on detail as Conscript Officer close of war.

Rucker, Joseph T.—Private Feb. 21, 1862. Killed at King's School House, Va. June 25, 1862.

Rucker, Russell J.—Private Aug. 31, 1861. Discharged, disability, Aug. 14, 1862.

Rucker, Simeon L.—Private Feb. 21, 1862. Wounded and permanently disabled at Chancellorsville, Va. May 3, 1863. Roll for Sept.-Oct. 1863, shows him in hospital. Petition on file.

Shirley, James L. (or Shurley)—3d Sergeant Aug. 31, 1861. Elected Jr. 2d Lieutenant Mar. 19, 1862; 2d Lieutenant in 1863. Captured at Gettysburg, Pa. July 3, 1863. Paroled at Johnson's Island, O. and sent to Point Lookout, Md. for exchange Mar. 14, 1865. No later record.

Shirley, William F. (or Shurley)—4th Sergeant Aug. 31, 1861. Discharged at Seven Pines, Va. June 28, 1862.

Gunn, R. C.—1st Corporal Aug. 31, 1861. Roll for Feb. 28, 1865, last on file, shows him present. No later record.

✱ **Rainwater, Cicero**—2d Corporal Aug. 31, 1861. Surrendered, Appomattox, Va. Apr. 9, 1865.

Littleton, Mathew H.—3d Corporal Aug. 31, 1861. Elected 1st Lieutenant May 13, 1863. Missing at Gettysburg, Pa. July 2, 1863. No later record.

Reese, Jesse—4th Corporal Aug. 31, 1861. Wounded, date and place unknown. Roll for Feb. 28, 1865, last on file, shows him absent, wounded. No later record.

Aldred, James Aaron—Enlisted as a private in Co. B, 48th Regt. Ga. Inf. Mar. 4, 1862. Transferred to Co. H, 22d Regt. Ga. Inf. Mar. 23, 1862. Killed at Spotsylvania, Va. May 14, 1864.

Aldred, M. W. (or Alred)—Private Aug. 31, 1861. Appointed 3d Corporal Nov. 1, 1864. Wounded at Hatcher's Run, Va. Feb. 6, 1865. Captured in Richmond, Va. hospital Apr. 3, 1865. Paroled at Salisbury, N. C. May 2, 1865. Admitted to 2d Division Army Corps U. S. Hospital May 20, 1865. Released May 29, 1865.

Aldred, Thomas Jefferson—Private Jan. 18, 1862. Wounded in right side and arm and captured at Gettysburg, Pa. July 2, 1863. Exchanged at City Point, Va. Aug. 1, 1863. Transferred to C. S. Navy in 1863. As landsman, Semmes' Naval Brigade, he surrendered at Greensboro, N. C. Apr. 26, 1865. (Born in Georgia Feb. 13, 1842.)

Anderson, William E., Jr.—Private Aug. 31, 1861. Appointed 3d Corporal Mar. 1862; 4th Sergeant Nov. 1, 1864. Surrendered, Appomattox, Va. Apr. 9, 1865.

Anderson, William E., Sr.—Private Aug. 31, 1861. Appointed Sergeant. Discharged at Seven Pines, Va. June 28, 1862. Appointed 2d Corporal of Co. H, 2d Regt. Ga. State Troops Feb. 16, 1863. Discharged, disability, May 15, 1863. (Born in Warren County, Ga. Nov. 14, 1841. Died in Atlanta, Ga. Sept. or Oct. 1918. Buried in Warren County, Ga.)

Armstrong, Alpheus—Private Aug. 31, 1861. Drowned in Potomac River, while on march to Gettysburg, Pa., June 23, 1863.

Armstrong, J. M.—Private Aug. 31, 1861. Died in Richmond, Va. hospital Dec. 14, 1862.

Armstrong, Robert H.—Private Aug. 31, 1861. Appointed 3d Sergeant in 1863. Captured at Gettysburg, Pa. July 2, 1863. Died at Fort Delaware, Del. Oct. 30, 1863.
