Whitfield, Sterling T.—Private Mar. 4, 1862. Captured at Vicksburg, Miss. July 4, 1863, and paroled there July 6, 1863. Roll for Dec. 31, 1863, last on file, shows him present. No later record.

Murchison, Alex—Captain Mar. 4, 1862. Retired to Invalid Corps May 5, 1864. "Assigned as Comdt. Cons. in Ga. May 30, 1864."

Williams, Jonathan N.—Enlisted as a private in Co. A, 35th Regt. Ga. Inf. Aug. 15, 1861. Discharged Nov. 8, 1861. Elected 1st Lieutenant of Co. K, 40th Regt. Ga. Inf. Mch. 4, 1862. Resigned, disability, in 1862.

Murchison, Rodrick—2d Lieutenant Mar. 4, 1862. Resigned Feb. 3, 1863.

King, James M.—Jr. 2d Lieutenant Mar. 4, 1862. Died at Knoxville, Tenn. May 5, 1862.

Perryman, M. A.—1st Sergeant Mar. 4, 1862. Died of disease in Tennessee Nov. 1862.

Philpot, William—2d Sergeant Mar. 4, 1862. Captured at Vicksburg, Miss. July 4, 1863, and paroled there July 11, 1863. Absent without leave Oct. 7, 1863-Feb. 29, 1864. Reduced to ranks Dec. 15, 1863. Pension records show he "Contracted chronic diarrhoea and rheumatism at Vicksburg, Miss. in 1863, and was unable for further duty." (Born in Ga. May 31, 1833.)

Murchison, John—3d Sergeant Mar. 4, 1862. Elected 1st Lieutenant Mar. 7, 1863. Captured at Vicksburg, Miss. July 4, 1863, and paroled there July 11, 1863. Roll dated Feb. 29, 1864, last on file, shows him on sick furlough. No later record.

Philpot, J. N.—4th Sergeant Mar. 4, 1862. Appointed 3d Sergeant Mar. 17, 1863. Captured at Vicksburg, Miss. July 4, 1863, and paroled there July 6, 1863. Reduced to ranks Dec. 1863. Absent, sick, Feb. 29, 1864. No later record.

Bain, K. M.—1st Corporal Mar. 4, 1862. Captured at Vicksburg, Miss. July 4, 1863, and paroled there July 6, 1863. Appointed 1st Sergeant Nov. 1863. Killed at Atlanta, Ga. July 22, 1864.

Williams, Mancel—2d Corporal Mar. 4, 1862. Deserted. Received at Louisville, Ky., a Confederate deserter, June 26, 1864, where he took oath of allegiance to U. S. Govt., and was released to remain north of Ohio River during war, June 28, 1864.

Ayers, William M.—3d Corporal Mar. 4, 1862. Discharged. disability, Dec. 12, 1862. (Born in Polk County, Ga. Mch. 28, 1840.)

* **Rainwater, John**—4th Corporal Mar. 4, 1862. Captured at Vicksburg, Miss. July 4, 1863, paroled there July 6, 1863, and left in hospital. Roll dated Feb. 29, 1864, shows him on sick furlough. No later record.

Aldridge, J. F.—Private Mar. 4, 1862. Deserted. Received at Louisville, Ky., a Confederate deserter, June 26, 1864, where he took oath of allegiance to U. S. Govt., and was released to remain north of Ohio River during war, June 28, 1864.

Alexander, J. A.—Private Mar. 4, 1862. Died at Knoxville, Tenn. in 1862.

Ayers, Hiram—Private Mar. 4, 1862. Died at Knoxville, Tenn. in 1862.

Ayers, Martin—Private Mar. 4, 1862. Died at Vicksburg, Miss. in 1863.

Bain, Donald M.—Private Mar. 4, 1862. Appears only on bounty pay roll dated Mar. 27, 1862. Enlisted as a private in Co. K, 18th Battn. Ga. Militia Cavalry (Murchison's) Mch. 1864. Appointed Sergeant Major. Surrendered at Kingston, Ga. May 12, 1865. (Born in Scotland Sept. 22, 1831. Died at Confederate Soldiers' Home in Atlanta, Ga. Aug. 9, 1931. Buried in West View Cemetery, Atlanta, Ga.)

Barry, J. W. C.—Private Mar. 4, 1862. Died at Vicksburg, Miss. July 20, 1863.

Bonds, Milburn—Private in 1862. Pension records show he "Furnished a substitute for three months. Returned to company. Served two years. Sent home on sick furlough from Vicksburg, Miss. in 1863. Did not recover sufficiently to return." (Born in Paulding County, Ga. Mch. 9, 1831.)

Bonds, Richard—Private Mar. 4, 1862. Absent without leave Oct. 7-Dec. 31, 1863. Deserted. Captured at Sandy Run, S. C., a Confederate deserter, Feb. 14, 1865. Forwarded from Fortress Monroe, Va. to Washington, D. C. Apr. 2, 1865, and received there Apr. 5, 1865. "Action taken: took oath of allegiance to U. S. Govt. and furnished transportation to Charleston, S. C." (Born in Calhoun County, Ala. Apr. 28, 1828.)

Bonds, Varda (or Verda)—Private Mar. 4, 1862. Died at Vicksburg, Miss. in 1863.

Brannon, W. T. (or Branan)—Private Mar. 4, 1862. Died at Knoxville, Tenn. prior to Jan. 27, 1863.

Bryant, J. A.—Private Mar. 4, 1862. Died at Knoxville, Tenn. in 1862.

Bryant, W. J. (or M. J.)—Private Mar. 4, 1862. Captured at Vicksburg, Miss. July 4, 1863, and paroled there July 16, 1863. Received off Mobile Harbor, Ala., on board S. S. Crescent, for exchange Aug. 4, 1863. No later record.

Camp, Thomas Lumpkin—Enlisted as a private in Co. O, Phil-

Rainey, Harvey A.—Private Apr. 15, 1863. Captured in Milton County, Ga., date not given. Sent to Louisville, Ky., where he took oath of allegiance to U. S. Govt., and was released to remain north of Ohio River during war, July 18, 1864. (Born in Ga. in 1839.)

Rainey, Ira Sanford—Private Mar. 4, 1862. Captured near Chattahoochee River, Ga. July 5, 1864. Sent to Camp Douglas. Ill. July 18, 1864. No later record.

★ **Rainwater, Pinkney F.**—Private Mar. 4, 1862. Discharged on account of chronic rheumatism Nov. 4, 1862.

★ **Rainwater, Sidney Y.**—Private Mar. 4, 1862. Discharged, disability, at Bean Station, Tenn. Aug. 2, 1862.

Revis, Thomas J. P.—Private Mar. 4, 1862. Roll to Apr. 30, 1862, last on which borne, shows him "Absent, detached to guard prisoners from Knoxville, Tenn. Apr. 20th." No later record.

Roddy, Alexander E.—Private Mar. 4, 1862. Roll dated Dec. 11, 1863, last on file, shows him present. Pension records show he was wounded and permanently disabled at New Hope Church, Ga. May 25, 1864. (Born in Ga. July 21, 1843.)

Roddy, F. C.—Private Apr. 15, 1862. Pension records show he was wounded at Bentonville, N. C. Mch. 18, 1865, and was in Charlotte, N. C. hospital close of war. (Resident of Ga. since 1845.)

Roddy, James Vernon—Private Mar. 4, 1862. Surrendered at Greensboro, N. C. Apr. 26, 1865.

Roddy, William T.—Private Mar. 4, 1862. Captured near Nashville, Tenn. Dec. 16, 1864. Deserted. Enlisted in 6th Regt. U. S. Inf. at Camp Chase, O. Mar. 16, 1865.

Scoles, Robert (or Scolds)—Private Mar. 4, 1862. Discharged. disability, Apr. 12, 1862.

Scoles, Simeon (or Scolds)—Private Mar. 4, 1862. Wounded at Cumberland River. Captured at Vicksburg, Miss. July 4, 1863, and paroled there July 6, 1863. Roll dated Dec. 11, 1863, last on file, shows him "Absent, sick in Milton County, Ga. since Sept. 18, 1863." No later record.

Sloan, Ransom F.—Private Aug. 15, 1862. Roll dated Dec. 11, 1863, last on file, shows him "Absent, left sick in Kentucky Oct. 10, 1862." No later record.

Spence, John T.—Private Mar. 4, 1862. Died in Ga. Oct. 22, 1863.

Spence, Miles Waddy—Private Mar. 4, 1862. Died of disease at home Oct. 22, 1863.

Thomas, John—Private Mar. 4, 1862. Roll dated Dec. 11, 1863, last on file, shows him "Absent, sick in Milton County, Ga. since Sept. 18, 1862." No later record.

Thomason, George S.—Private Mar. 4, 1862. Died of disease at Danville, Ky. date not given.
