In consideration of \$50 to me paid by Benjamin Chapman, have granted, sold and released a lot in the town of Pickens Court House #45. Containing one acre, lying on the North side of the Court House. Dated this 20 Aug. 1820. Wit: Samuel Reeder Barnet Neighbors. Signed Johnathan Reeder. Proved on oath of Barnet Neighbors before William L. Keith C.C. this 6 Sept. 1830.

Reid, Joseph. Book 1, Page 1-4. Probate Judge Office. Pickens, S.C. (Only part of will in notes.) I Joseph Reid of Pendleton Dist. being of sound mind, memory and understanding. First I will my just debts be paid... To my son Thomas Basher Reid, I give the land I own on the East side of Keowee, containing 650 acres. Bound by land of John Ewing Colpouh Esq.? and Jesse Spaers. Also two negroes boys and half of the farm tools... To my son Samuel Reid the land on the West side of Keowee, containing about 900 acres. Also half of the farm tools, also four negroes named Jack, George, Reuben, Gaston. To my wife Issabella Reid two negroes named --- and woman named Hannah, with all household and kitchen furniture, stock during her natural life---. Isabella & Thomas B.Reid qualified as executors on 15 Dec. 1828. Before J. H. Dendy, Ord.

Rivers, Francis Milligan. I appoint my sons John Floyd Rivers and Francis M. Rivers, executors... Dated this 13 March 1847. Wit.: H. N. Walker, Carter Newsome, Mayberry Howell. Signed Thomas Rivers. Proved on oath of Hyram N. Walker and Mayberry Howell, before P. N. Maddux, C.C. on the 3 Sept. 1849. Recorded the 8 Sept. 1849.
